What is the rule of capture - ANSWER-Landowner is entitled to all the oil & gas he may bring to the surface even if he causes migration or drainage from another's land

Limits

Limited by correlative rts of adjacent owners - owes legal duty not to exercise privilege in harmful manner (ie no RoC for stored gas, illegally or neg drained gas)

Production Payment

What are fee simple interest & severance - ANSWER-FS owners own both mineral and surface rights; may transfer less than his entire interest through SEVERANCE

A "mineral deed" conveys mineral interest in fee, for life, or term of years

What are the mineral interest owner's rights - ANSWER-Development Rights: exclusive rt to explore, produce, & develop land

Executive Rights: rt to lease the property

Lease Benefits: bonus (upfront payment for signing lease), royalty (fractional share of production free of cost), & delay rentals (deferring drilling)
